RESOLUTION NO. 001, Series of 2023

A RESOLUTION RECOMMENDING THE APPOINTMENT OF MR. KING DANIEL C. JACINTO AS THE NEWLY APPOINTED BARANGAY SECRETARY OF BARANGAY 17, CAGAYAN DE ORO CITY.

WHEREAS, after the October 2023 Barangay Election, the position for Barangay Secretary of Barangay 17, Cagayan de Oro has been vacant;

WHEREAS, the resulting vacancy of Barangay Secretary where the rule of succession is no longer applicable shall be filled up by appointment to be issued by the Punong Barangay upon the recommendation and approval of Sanguniang Barangay concerned;

WHEREAS, MR. KING DANIEL C. JACINTO has an edge in all the qualifications and none of the disqualifications for appointment as Barangay Secretary of Barangay 17, Cagayan de Oro City;

WHEREAS, the appointive official is one who acquired official relation to his office by way of appointment in accordance with law. In such case, his official relation to the office through appointment is considered as an APPOINTIVE OFFICIAL because he is occupying an Appointive position;

NOW THEREFORE, on motion of Barangay Kagawad Jigger John P. Ebabacol, duly and UNANIMOUSLY seconded by the Sangguniang Members of Barangay 17, Cagayan de Oro;

BE IT RESOLVED, as it is hereby resolved by the Barangay Council in session assembled that a resolution recommending and approving the appointment of MR. KING DANIEL C. JACINTO as the Barangay Secretary of Barangay 17, Cagayan de Oro.

RESOLVED FURTHER, that copies of this resolution be forwarded to government offices concerned for their Information and guidance.
